## Infrastructure

### The Campus

Vidyabharti College of Pharmacy is located on its own land with its infrastructure at the center of Amravati. 2 km from Amravati Railway Station and 10 km from Badnera Railway Station & 1 km. from Amravati Bus Stand.

A beautiful campus of the Institute is sprawled in an area of 2.5 acres in picturesque surroundings providing a refreshing environment, stimulating intellectual alertness and creativity. The Campus has facilities for Canteen, Mess, Hostel, Playground, Indoor games Stadium, Gymnasium & Auditorium. The campus provides an ambience that motivates students to grow. The institute building has modern amenities. The post graduate laboratories are independently developed for M.Pharm. and Ph.D, students. Apart from this, the campus has sports facilities and over all ambience is distinguishable by serenity, which is conducive for intellectual pursuits.

### Laboratories

The Institute has Separate laboratories for post graduate, undergraduate & diploma students. The laboratories are designed and equipped with several state of the art technologies, which are the setting for instructing in the evolving needs of the pharmacy profession i.e. Pharmaceutical and Health care industry. The laboratories are spacious and ventilated, having adequate space for students to carry out experimental work smoothly.

The laboratories are well equipped with various sophisticated instruments & machines required for imparting knowledge to the students.



### Class Rooms

The Class rooms are spacious, ventilated and equipped with multimedia and Interactive equipments to facilitate effective learning. The class rooms are designed to provide maximum interaction between faculty and students.



### Computer Centre

Computing facilities for students include a laboratory equipped with 44 computers to the Recent Windows server and Local Area Network and Wi-fi facilities. Optical Fiber Cabel installed in the 10 mbps plan VPN Network. The network also connects the faculty and staff for information sharing and communication. The students have an easy access to the Internet. The faculties are also provided computer and internet





## Spectroscopy

The Institute houses modern analytical Instruments like HPTLC, HPLC, FTIR, Fluorescence Spectrophotometer, GC, UV-VIS Spectrophotometer Atomic Absorption Spectroscopy, which provide analysis comprising elemental composition, chromatography, diffraction, particle/material Characteristics including various spectrometers. The laboratory provides analytical support and intellectual input to both in-house and externally founded R&D projects.

## Animal House

VBCP has state of the art animal house facility registered by CPCSEA, Government of India. It is envisaged to provide preclinical testing in conformity with national and international regulatory guidelines. The animal house facilitates the availability of healthy and homogeneous animals for U.G. and P.G. studies and research/outsourced testing.

## Pilot Plant

The Institute has developed a well equipped Pilot Plant for formulation, design and development of dosage formulation. It is equipped with various sophisticated machineries required for imparting knowledge to the students regarding various formulation processing and testing equipments used in the manufacturing of pharmaceutical dosage forms like tablet, capsules, liquids, semisolids, parenterals and novel drug delivery systems. Rotary tablet machine, fluidized bed dryer, spray dryer, freeze dryer, automated dissolution apparatus, different mixers, automated ampule filling and sealing machine, digital tablet tester and R15 Rheometer are the Vital instruments in the pilot Plant.

## Medicinal Garden

A medicinal Plants garden has been developed in the campus & various medicinal plants have already been planted. The Medicinal plant garden provides a strong impetus for herbal drug research and for training the P.G. and U.G. students.



## Learning Resources Centre (Library)

In VBCP it's a belief to facilitate production and dissemination of knowledge, information, insight & intellect in all scientific communities. The library plays a vital role in the collection, development and dissemination of scientific and technical information to meet the present and future academic and research needs of varied users.

Presently the library at Institute houses more than 14797 volumes and 3139 titles of books, and indices selectively chosen for reading and reference, 150 project reports (B. Pharm.) 294 Research project (M. Pharm.), 07 Ph. D. Thesis and subscribes about 47 printed national, 15 international periodicals, E-journals and 10 news papers, 10 Magazines for competitive exam & a well developed digital library with "Delnet" subscription & NDLI

# RULES OF DISCIPLINE

- Students should be regular and punctual in attending classes, tutorials and submission of the term-work. A student will not be allowed to appear for examination if his/her progress, conduct and attendance are not satisfactory.
- Student, if found indulging in anti-national activities, contrary to the provisions of the Acts & Laws enforced by Government will be liable to be expelled from the college without any notice by the Principal.
- Ragging of students in any form within or outside the college premises and Hostel is strictly prohibited. Defaulters will be strictly dealt with as per Govt. rules in this matter.
- Smoking, drinking (alcohol) and use of Drugs is strictly prohibited in the premises of the College and Hostel. Bicycles, Scooters and other vehicles should be parked only in areas provided for the purpose. The Institute accepts no responsibility for their safe custody. Vehicles lodged elsewhere may be confiscated.
- Any changes in the address of the student must be intimated by him/her in writing to the college office immediately.
- Students must wear college uniform & carry Identity Card signed by the principal and produce the same whenever asked by the college Authorities. Without Identity Card & Uniform students will not be allowed to enter the college premises and will be strictly dealt with.



- In case, a student wants to remain absent for some reason, he/she will be required to take the prior permission of the Principal. Students with less than 75% attendance will be debarred from the exam
- If any of the statements made in the application form or any information supplied by the student in connection with his/her admission is at any time later found to be false or incorrect, his/her admission will be cancelled, fees forfeited and he/she will be expelled from the college by the principal and prosecuted if necessary.
- A Student shall not go to the press or any other publicity media without taking prior permission of the principal.
- Any damage to the college property, apparatus, furniture, equipment, library books, building, etc. must be made good immediately by the student concerned.
- Students must attend social and National programs organized by the College such as 26th January, 15th August and all other academic and cultural programs organized for the students.

## Discipline

The Institute has earned a name for quality education, this is due to the efforts and devotion of well qualified faculty of the Institution. The academic calendar for whole year is notified in the beginning and is strictly adhered to. Student's attendance is compulsory and shortfall is notified. It is expected of every student that he/she should conduct himself / herself with discipline, decency and dignity both inside and outside the campus. The institute sends progress & attendance reports of the students to their parents periodically with a view to keep them informed.

## Dress Code

It is compulsory for all the students to attend college in the prescribed uniform and with college Identity card.

## Ragging is Prohibited

Ragging is strictly prohibited inside and outside the institute campus. The Anti ragging committee constituted for this purpose by the Institute is empowered to take immediate action against any untoward incidence and also to counsel the freshers. Students seeking admission shall have to furnish undertaking in this regard.

If any incident of ragging comes to the notice of the member of the anti ragging committee placed by the institution, action shall be taken against him/her as per provision of the Maharashtra Prohibition of Ragging Act 1999 which may lead to expulsion of student from the institute

## Important Instructions

- Duplicate T.C. will not be entertained.
- At the time of admission, the applicant must produce . the original leaving certificate /Transfer certificate and Scholarship students should submit the original caste certificate, caste Validity certificate, Non Creamy layer certificate, Income certificate.
- Student of any other University should submit a Migration certificate on or before 25 August, signed by the Registrar of the University from which he/she has migrated and also pay the immigration fee. Students not already enrolled - in-S.G.B.Amravati University will have to pay the University Enrollment fee at the time of admission.
- Students once admitted to a regular course of study in this University shall not be permitted to appear for any other examination simultaneously.
- No separate intimation will be sent to the home "address. Applicants are advised to see the information concerned on the notice board.
- Students shall have to obey all the instructions of the principal. They will be directly answerable to him/her for their behaviors in general, both inside and outside the college. The names of such students found violating the rules of the college administration or behaving in an undisciplined manner will be removed from the college rolls. It will be presumed on admission that the students concerned and their parents and guardians have read and concurred with these rules.





## Fees

The annual tuition fees and other fees shall be as prescribed by the Fees Regulating Authority Constituted under Maharashtra act No. XXVI11 of 2015 for the academic year.

Fees is to be paid through Challan given by college and should be deposited in Bank or can be paid by net banking also.

The concession of fees under Economically Backward Class, Government Scholarship to backward class, etc, will be granted as per norms of Government of Maharashtra.

Free Ships, Scholarships are available to the B.C. Minority, E.B.C. Students as per Govt, of Maharashtra Stipend is also paid to eligible PG. Students as per A.I.C.T.E. norms & Rules of Maharashtra Govt.
